Ordinance Number 24-02 Regulating, Limiting and Restricting the Weight of Commercial Vehicles Operated on Residential Streets but Excepting Normal Commerce

Proposed Ordinance's Ordinance Number and Short Title:

This Business Impact Estimate is provided in accordance with section 125.66(3), Florida Statutes. development agreements and development permits;

d. Section 633.202, Florida Statutes, relating to the Florida Fire Prevention Code.

In accordance with the provisions of controlling law, even notwithstanding the fact that an exemption noted above may apply, the Town hereby publishes the following information:

1. Summary of the proposed ordinance (must include a statement of the public purpose, such as serving the public health, safety, morals and welfare):

Conditions for the operating of heavy vehicles in the interest of public safety and convenience as well as the preservation of infrastructure.
