Ordinance 25-01: Adopting a Comprehensive Revision of the Land Development Code

This Business Impact Estimate is provided in accordance with section 125.66(3), Florida Statutes. 1. Summary of the proposed ordinance (must include a statement of the public purpose, such as serving the public health, safety, morals and welfare):

This ordinance is a comprehensive revision of the Town's land use and development ordinance, covering all aspects of the procedures for applying for and obtaining approvals, and detailed planning and zoning specifications.

2. An estimate of the direct economic impact of the proposed ordinance on private, for-profit businesses in the Town, if any:

(a) An estimate of direct compliance costs that businesses may reasonably incur;

(b) Any new charge or fee imposed by the proposed ordinance or for which businesses will be financially responsible; and
